Project Manager Position ~ Tātau Tātau o Te Wairoa Trust has completed the recruitment drive to contract a Project Manager. We are pleased to announce the appointment of Ropata Rotohiko Ainsley to this position. The role of the Project Manager is to provide support to the Board in the initial 2 year period of Tātau Tātau o Te Wairoa with a primarily focus on key Kaupapa contained within the Trust Deed. Namely, to carry out a review of the ownership arrangements for the Trust Assets and the representative arrangements for the Trust. The Project Manager will also be responsible for assisting with the outstanding settlement matters and implementing key operational processes, systems and controls.

Kaumātua Council ~ The Kaumātua Council held their inaugural meeting on the 15th September at the Wairoa Community Centre. Trustees are appreciative to all kāhui/clusters for fulfilling the positions of their two members to the Kahui Kaumātua Council. Since the inaugural hui, the Council has reviewed the draft terms & reference and considered their roles, responsibilities and as importantly, how they can best support Tātau Tātau and all members. The next Kaumātua hui is on the 31st of October at the Vista Motor Lodge at 11am.

Consultation Round 2 ~ The 2nd round of consultation on the final model for our asset and representation arrangements commences at Wairoa on Friday 3rd November, followed by Napier 4th November and Wellington 5th November. During the 1st round of consultation throughout August, Tātau Tātau said they would consider the feedback given and return in November with 2 or 3 models. Two models will be proposed in the November consultation for all members to consider and provide feedback as well as a proposal around independence. It is intended that the feedback from the November consultation will lead to a single model proposed for ratification early in 2018.
